

Remote Learning Plan (Students learning from home online)

Proper student learning environment-REQUIRED

- all classroom teachers will begin "Live Streaming through Zoom" at 9:00am
- remote students/ learners report to their homeroom class by 9:00am
- attendance taken 9:00am whole school
- attendance taken every class period for grades 4-8
- uniform St. Mary logo shirt required grades 1-8, (refer to student/ parent handbook)
- remote learners are required to stream through ZOOM and participate in the classroom for the full school day
- inside home/ dwelling setting must follow proper classroom rules and etiquette and posture
 - seated at a table
 - seated upright, shoulders and face present in the online/ zoom camera window at all times
 - o no laying down, no bed, no couch, etc...
 - o use online hand feature and wait to be called upon
- outside setting must follow proper classroom rules and etiquette and posture
 - seated upright, shoulders and face present in the online/ zoom camera window at all times
 - o no laying down, no bed, no couch, etc...
 - use online hand feature and wait to be called upon
- quiet surroundings
 - siblings and pets do not/ should not attend class
 - respectful
- students will follow St. Mary Catholic Schoo's traditional meal routines
- lunch, recess and study hall do not need to be live streamed
- necessary school supplies at your work table (paper, pencils, books, etc..)
- parents (with no participation) will need to be accessible while students are online for primary students
 - parents will be responsible to download, scan, print, and email back to teachers at required times.
 - o assessments taken at same time as in class students
- students 4-8 will have own chromebooks (need to sign insurance agreement and pay insurance)
- students K-3 can use a school chromebook (need to sign insurance agreement and pay insurance)
- assignment materials will be posted by the teacher by 6:00pm the day before the assigned work
- completed student work is returned to teacher by 9:00am the next day
- report card will state remote learning

- remote learning is *required enrollment of 1 quarter at a time*, first quarter begins 8/26/20 at ends 10/28/20
- 2nd quarter starts 10/28/20
- returning registered students ARE guaranteed a classroom seat the second quarter if you have selected Remote Learning for the first quarter.

Sick Student Learning (For remote learners) (Absent student due to illness)

All classroom lessons will be taped and available on Google Classroom. Your child is responsible in completing the assigned classwork & homework in accordance to the rules stated in the Student/ Parent Handbook, once they are feeling better.

<u>Proper student learning environment for sick students- REQUIRED</u>

- call the office when student sick or quarantined by 9:00am
- teacher will record daily lessons for home access for sick student
- you will discuss make up work and assessments with your classroom teacher
